### What is the purpose of this update?

This document tells you how the Pathfinder Green Bond Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pathfinder Asset Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this Fund**

The Fund invests in fixed income securities that are classified as "Green Bonds". The Fund's investments are managed by MetLife Investment Management.

### What are the risks of investing?

Potentially Higher Returns


#### How has the fund performed?


### Example of how this applies to an investor

Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela received a return after fund charges were deducted of \$396 (that is 3.96% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total return after tax of \$285 for the period (2.85%).

The top 10 investments make up 39.37% of the net asset value of the fund.

Currency hedging: Changes in the value of the NZ dollar relative to other currencies can have a big impact on your investment over the long term. The target currency hedging level implemented in the fund is 100% of foreign currency exposures (actual hedging level at 30 June 2024 was 98.90%, this will change over time). The unhedged foreign exposure was 1.05% of the Net Asset Value of the fund at 30 June 2024 (this will change over time).
